### **Sharing Session...**

Shelie V. called for a vote on the donation to the region. GSRs approved a \$200.00 Donation.

Teresa F, Mike W, Cory F, and Ali M. discussed Motion 1, and it was determined, per the guidelines, that GSRs are in fact, area service positions. The guidelines state “NA groups send... (GSRs) to serve on the area committee” ( 2<sup>nd</sup> heading “The Area Committee and Other NA services, First Sentence)

Teresa F, Mike W, Ali M, and Cory F, discussed the guidelines pertaining to candidates in reference to 6.3 in the guidelines which states that a service member must OFFER their resignation of one service position, before being voted on for another one, and that resignation will be considered in new business. It does NOT state someone CANT hold 2 service positions at the same time, which is what motion 1 was trying to establish. (Motion 1- (6.2 e) may not hold 2 area positions at the same time. This includes GSRs” )

**6.3 Candidates: must offer their resignation of any Area Trusted Servant position held immediately prior to the election, and such offered resignation shall be considered during New Business.**

Teresa F, Shelie V, Mike W, Jacon C discussed the problems of different sub-committees being limited to only 1 hour at area, AASC waiting on H&I, OASC waiting on AASC, and H&I having to rush through its growing nominations. H&I was urged to discuss in its next subcommittee meeting whether or not to start 30 mins earlier, and each sub-committee to discuss a 15 min window between different subcommittee meeting, during their July meetings.
